Budget highlights:

- The budget details were reported and are also on the website.
- It is advised that committee chairs wait until 60% of your committee budget is spent before requesting additional budget.
- Reminder that vouchers must be signed by the committee chairs
- The original receipt must be attached to the voucher
- Receipts should contain only the items purchased for Delta approved activities
- Include a copy of the budget to support the purpose for the purchase
- · Reimbursement checks are signed before each EBoard or chapter meeting
- The budget was modified to reflect 48 additional members
- <u>RECOMMENDATION</u>: Add \$500 to the National Convention budgeted line item for delegate for travel related costs.
 - Discussion: the line originally had \$150 budgeted
 - The remainder collected from membership dues to contingency: \$8,230
- The recommendation was properly made by the committee and passed with a vote of 23-1.

Emergency Response – Soror Suzanne Piper

- The message from headquarters is that each chapter needs to decide mask and vaccination requirements and
 present for a vote by EBoard and the chapter to have in-person meetings.
- <u>RECOMMENDATION</u>: Motion to include in the in-person COVID safety plan that members of the chapter be vaccinated and/or wear masks.
 - General discussion: Honor system for vaccination status or just require masks? The latter does not require the obligation to prove vaccination status. It was commented that the upcoming National Convention requires that a vaccination card be presented for entry.
- AMENDMENT #1: Strike the vaccination language so that masks are required to all in attendance at meetings. The motion for the amended language was made, seconded, and passed with a vote of 22-1.
- AMENDMENT #2: Motion to strike the words "of the chapter" was made, seconded, and passed with a vote of 20-1
- The amended recommendation was made, seconded, voted upon and passed with a vote of 21-0.

Policies and Procedures – Soror Patricia Shorter

- The Policies and Procedures Committee recommends approval of the amendments proposed by the National Constitution and Bylaws Committee (NCBC). Delegates will vote on the amendments during the 55th National Convention on Nov 19-22 in Atlanta, Georgia.
- The RECOMMENDATION was properly made, voted upon and passed with a vote of 16-1.
