Social Action - Soror Jeri Brooks

- <u>RECOMMENDATION #1</u> Austin Alumnae to donate the remaining Social Action Budget from FY21-22 to the Good Works Austin organization.
- Soror Diwi Smith on the Board of Directors. The remaining amount of budget estimated to be available for this donation is \$1,000.
- The motion was properly made by the committee, voted upon, and passed with a vote of 110-3.
- RECOMMENDATON #2 Austin Alumnae to donate the remaining Social Action Budget from FY21-22 to the Central Texas Food Bank.
- Soror Lisa Newman spoke in favor of the recommendation stating its alignment to the commitment to solve food insecurity. The remaining amount of budget estimated to be available for this donation is \$1,000.
- The motion was properly made by the committee, voted upon, and passed with a vote of 104-1.

Standing Committees

Policies and Procedures - Soror Patricia Shorter

- The proposed edits to the Policies and Procedures were presented to the body.
- The options were provided to vote in the following ways.
 - o Unanimous consent i.e. no questions, no modification as presented
 - o Unanimous consent with object to specific areas i.e. address the areas receiving objection as presented
- The Policies and Procedures includes the fundamental rules defining the chapter
 - o Approved by the chapter
 - Allows the chapter to meet constitutional requirements, work effectively, solve problems, maintain control and manage chapter affairs.
- P & Ps have been updated in accordance with the mandated template issued by the National Scholarships and Standards Committee
- P&P Committee conducted a chapter Q&A session to discuss the new template, recommendations, and updates on 4/14/2022
- Four recommendations were received during the comment period ending 12/31/2021.
 - o Art III, Sec 1B9, First VP serves as the Leader of the Minerva Circle during Membership Intake
 - Art IV, Sec 1R9, Technology Chair must have attended at least 2 of the 3 National Conventions and 2 of the 3 regional conferences held prior to her appointment



- o Art IX, Sec 1D The President, First VP, and Second VP and Financial Secretary must have attended at least 2 of the 3 National Conventions and 2 of the 3 regional conferences held prior to her appointment
- Art at least 2 of the 3 National Conventions and 2 of the 3 regional conferences held prior to her appointment
- o Art X111, Sec 3A-B
 - A. Delta Days in the Nation's Capital (DDNC), the Social Action Chair and Co-Chair will serve as representatives of the chapter.
 - B. Delta Days at the United Nations (DDUN), the Social Action Chair and Co-Chair will serve as representatives of the chapter.
 - Note: the Art X111, Sec 3A-B amendment was accepted by the body as submitted.
- New template color coding
 - Black print is required per governing documents and/or Constitution and Bylaws and should not be altered
 - o Red print would be unique to the chapter and can be changed. Do not delete, just strike through.
 - o Blue print represents where items can be added that are unique to your chapter management.

RECOMMENDATIONS discussions and votes from the AAC body

- Art III, Sec 1B9, First VP serves as the Leader of the Minerva Circle during Membership Intake
 - o Discussion consider the duty workload of the 1st VP before making it a requirement to also be the Leader of the Minerva Circle; adding the requirement may make one re-consider vying for the 1st VP position. The logic for the proposal was that the 1st VP has access to the Red Zone which helps greatly with the tasks associated with membership intake. Soror Kacey Hanson and Soror Michelle Scruggs spoke in favor. Soror Lisa Newman also spoke in favor stating that this arrangement is becoming a chapter norm. She continued that the recent National President's Town Hall illustrated the First VP having this role.
 - The motion was properly made, seconded, voted upon, and did not pass with a vote of 72-3. The number needed to pass was 74.
- Art IV, Sec 1R9, Technology Chair must have attended at least 2 of the 3 National Conventions and 2 of the 3 regional conferences held prior to her appointment
 - o Discussion Soror Jones was not in favor of the item as written. The reason stated is that the requirement is excessive for this position that may be attractive for a newer soror.
 - The proposed language would read as follows: Art IV, Sec 1R9, Technology Chair must have attended at least 1 of the 2 National Conventions or 1 of the 2 regional conferences held prior to her appointment
 - The motion was properly made, seconded, voted upon, and passed with a vote of 91-14
- Art IX, Sec 1D The President, First VP, and Second VP and Financial Secretary must have attended at least 2 of the 3 National Conventions and 2 of the 3 regional conferences held prior to her appointment
 - o Discussion #1 Changing the language FROM at least 2 of the 3 TO at least 1 of the 2. Reasons include the difficulty experienced registering a conference from Soror Tamala Saldana.



- The proposed language would read as follows: Art IX, Sec 1D The President, First VP, and Second VP and Financial Secretary must have attended at least 1 of the 2 National Conventions and 1 of the 2 regional conferences held prior to her appointment
- o The motion was properly made, seconded, voted upon, and passed with a vote of 81-20
- Discussion #2 Changing the language FROM at least 2 of the 3 TO at least 1 of the 2; and changing the language FROM National Conventions and Regional Conferences TO National Conventions or Regional Conferences. Soror Alexis Johnson reason for changing "and to or" was the cost unaffordability to collegiates. Soror Kacey Hanson spoke out against changing "and to or" and asked the AAC body to consider that requiring that [low] number of attendances for key positions like the Chapter President and Vice President is not enough.
 - The proposed language would read as follows: Art IX, Sec 1D The President, First VP, and Second VP and Financial Secretary must have attended at least 1 of the 2 National Conventions or 1 of the 2 regional conferences held prior to her appointment
 - o The motion was properly made, seconded, voted upon, and did NOT pass with a vote of 33-60.
