Greetings Sorors,



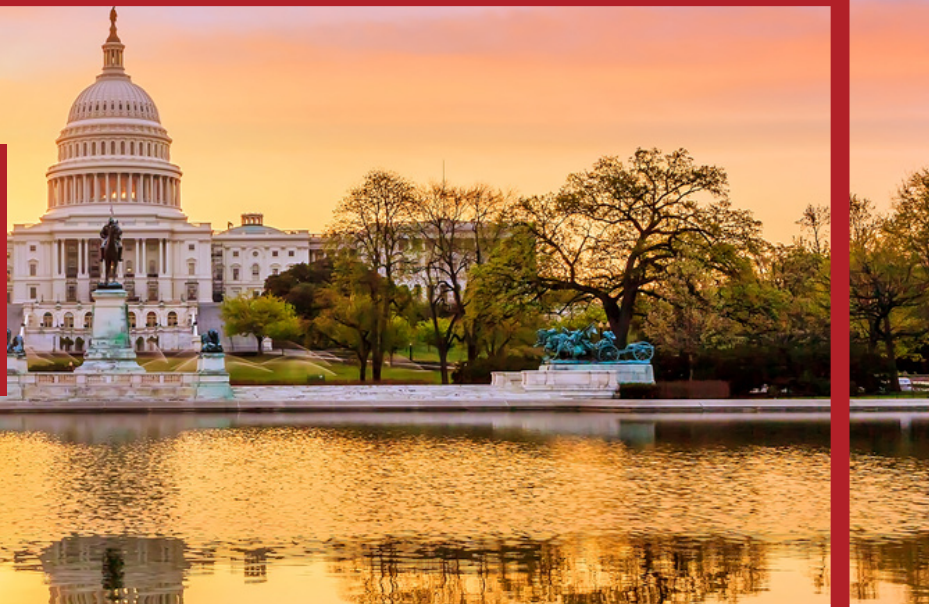

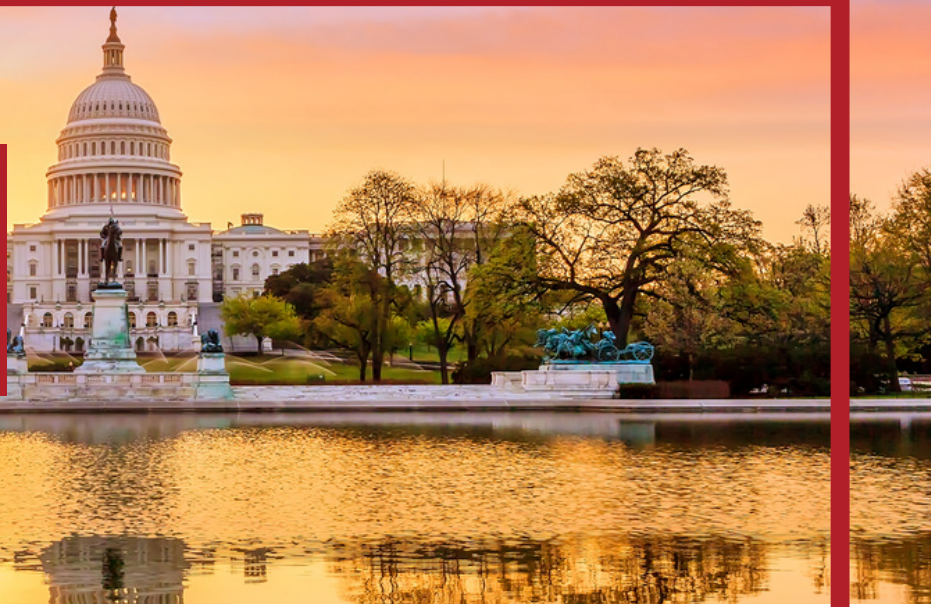
